Sub: Debarment of M/s. Radhe Pack Industries for non-completion of purchase order.

2. Show cause notice dated 26.03.2026.

The GeM contract no. GEMC-511687752698996 dated 07.03.2025 was placed on you for Supply of Corrugated Boxes (50,000 nos.). You had supplied 40,281 nos. of boxes in staggered delivery out of ordered 50,000 boxes as per RCF requirement. RCF vide email dated 30.12.2025, informed you to deliver the remaining 9,719 nos. of boxes. Several follow-up emails dated 19.01.2026, 05.02.2026, 10.02.2026, 16.02.2026, 20.02.2026, 25.02.2026, 26.02.2026, 04.03.2026, 06.03.2026, 07.03.2026, 17.03.2026 were sent. However, you did not reply to RCF emails.

During a telephonic follow-up, you informed RCF that you were facing transportation-related issues. Accordingly, you were advised to dispatch the material through courier services in the event that vehicles were not available for direct transportation. Despite several follow-up emails and telephonic communications, you neither delivered the material to RCF nor provided any written commitment regarding the supply of the material.

RCF vide its show cause notice dated 26.03.2026 has already intimated you that you have failed in performance of your contractual obligations and in case satisfactory explanation is not received, the action would be initiated against you as per the term and conditions of the Contract.

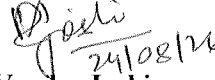
You did not reply to the show cause notice. You have failed to complete the supplies against the purchase order as per contractual terms and conditions.

Under these circumstances, we are constrained to inform you the following:

1. M/s. Radhe Pack Industries is debarred from participating in any procurement process of M/s. Rashtriya Chemicals and Fertilizers Limited for a period of Six Months from the date of this debarment order.
2. Security Deposit @5% Rs. 62,366/- is forfeited.
